Bid security amount (EMD) & Validity	EMD Amount: The bid security/EMD amount shall be equal to INR 7,40,000/- (Indian Rupees Seven Lakh Forty Thousand Only), and it shall be in the form of NEFT/RTGS/e-BG from any Scheduled Bank in India. Validity: In the case of EMD by e-BG, it shall be valid for 208 days from the date of the stipulated Bid submission due date. Bidders shall upload the scanned copies of e-BG details or transaction receipts of NEFT/RTGS payments along with online bid submission.

Bid submission fee (Non-refundable)	There will be a non-refundable Bid Submission Fee of INR 24,000/- (Indian Rupees Twenty-Four Thousand only) inclusive of GST to be paid in the form of a NEFT/RTGS transaction.
